#### 1. World Panel

Before getting into the Panel nominations, the Waterski Council had discussed the scenario where officials may be appointed in the same official position in successive events with the same World Title, and that some of them may be proposed for selection in any Official capacity for three successive events at the same world title.

The above specifications were inside the IWWF Bye-Laws until 2017 but were removed in the 2018 version. Waterski Council with the agreement of the IWWF President Jose Antonio, believe that for World Events we have to appoint the best possible panel from the names proposed by the relative Confederation Council no matter if they have already been appointed in previous Championships.

## 2. Duration of an Homologation

There has been some controversy on the interpretation of the following rules:

#### **25.01: General**

It is the duty of each skier to report to the Chief Judge during the competition if he believes the rules are not being followed or adhered to. The issue will be addressed at the competition.

If a competition is at the same site on subsequent weekends, the Homologator may decide not to carry out another full homologation but make enough checks to satisfy himself that nothing has changed. The Homologator must be present during the competition.

The Waterski Council agrees that for different competition the meaning of "subsequent weekends" is one following the other (five days in between) and this has to considered as the original interpretation of the rule.

#### 3. Score on same site.

A request has been submitted to allow, for the use of Ranking, scores from the same site.

After discussion the WSC has decide that for the November 2021 Ranking, the following apply:

A singular score (vs an avg of two) will place a skier on the ranking list. However, the second score from the same site would not be used to calculate rank.

If a skier only has one score, this skier will be rank below all other skiers who have the same best score and a backup scores for an average from a different site.

### 4,5 & 6: Eligibility Rules & Exceptions for the 2020/2021 IWWF Waterski Championships.

We have received various requests for exceptions from the organizer of the 2021 World Championships, all those requests have been discussed and summarized into the enclosed document.

#### 7. BFLSL5F.

WSC has reviewed the submitted video and tricks descriptions

The trick has been approved; the point value is 950.

For the point value, until a full revision of the whole tricks point values, the usual procedure has been adopted: adding 50 points to the existing trick with 180° rotation less.

### 8. Augustina Varas Jump record, events in Chile.

There is a PANAM investigation going on about some events in Chile, before taking any decision, regarding the record, the WSC had decided to wait until the investigation is completed.

While compiling those minutes the following decision has been taken:

- On March 23, the Waterski and Wakeboard Federation has requested the withdrawal of the application for recognition of the U17 female jump world record of our athlete Agustina Varas due to the inconsistencies of homologation detected on an internal second review.
- The PANAM TC, after reviewing the background of the different tournaments in Los Morros the following tournaments have been downgrade to class C in slalom and jump: 21CHI016, 21CHI006 and 21CHI019.
