# 3. Warm Up for World Open Officials

During the 2020 and 2021, there have been fever opportunities for officials to Judge skiing performance at high levels. To assist the World Championships Jury, the proposal is to provide additional training before the World. This will be accomplished by providing access to different tricks and slalom video which must be viewed before the Worlds.

The video will not be scored, but will be used for training purposes and to assist in assigning jury panel to the events for which they are most qualified.

All appointed Judges (including the 2 alternates) will need to take the L1 tricks test, results will be used to help the Chief Judge to assign the Jury panels.

The Officials that do not pass the test will not be in any tricks calling panel.

## 1) Course Change do to weather forecast prevision.

Robert Ritter comments: Here is a point that I would like us to review about tomorrow.

In worlds U21, due to wind forecast the position of the ramp was modified.

To avoid misunderstandings in the World ahead, perhaps it is good to define that:

The use of one or another ramp is not only conditioned to the weather of the moment, but also to the weather forecast.

This decision must be made by the appointed judges on the basis of the proposal of the Safety Officer and the Chief judge.

Any decision on courses change will be taken by the Chief Judge, Safety Director and appointed Officials.

## 2) 2023 IWWF World U-21 Championships

"The Chilean Federation is asking for the possibility of biding to hold the 2022 U17 and the 2023 U21 together as we are doing now.

Personally, I believe it is very taxing on the officials so should this be approved, they would need to be compensated appropriately, additionally, it is much farther to travel for most countries so a two-week tournament will be hard on parents and skiers.

As you see, I'm not too encouraged about this but I want your council to think about it before putting this possibility to the bureau. On informal talks with stakeholders I cannot find a lot of support."

Jose Antonio has explained the requests, WSC has decided to take some time before making the final decision.
